



2021 marks new phase of development for SENVIC

Social Enterprise Network Victoria (SENVIC) is proud to herald a new phase in the growth of Victoria's social enterprise community.

SENVIC was established in early 2018 by a group of nine pioneers in Victoria's social enterprise community, to connect, develop and be a voice for social enterprise. The founders have guided the development of SENVIC for three years, building a community of over 700 members today.

Following incorporation of Social Enterprise Network Victoria Ltd, the founding members have become non-executive Directors of the new company under its constitution and governance arrangements. This time of development is also a time for renewal with two non-executive Board vacancies arising in 2021.

Matt Pfahlert, a founding member of SENVIC and CEO of the Australian Centre for Rural Entrepreneurship (ACRE) and Social Enterprise Academy Australia, has left the Board. ACRE continues to be a key delivery partner for SENVIC's regional network and learning and development activities. SENVIC wishes to acknowledge and thank Matt for his pivotal role in the formation of this state-wide network and in particular his involvement in the development of the regional network throughout Victoria.

"As a long time practitioner, I've always believed that the voice of 'lived experience' should be at the table as the social enterprise sector gathers momentum in Victoria" said Matt. "So I was thrilled when Equity Trustees through Natalie Elliott and more recently Ferdi Hepworth partnered with ACRE to establish SENVIC. I'm incredibly proud of the work and commitment of the founding members and as the organisation grows, the time is right to focus greater attention on supporting the sector through learning and development programs delivered by ACRE and Social Enterprise Academy Australia. I'm most excited that SENVIC is an independent voice for a new generation of social entrepreneurs wanting to connect, be supported and find their tribe."

For the past 10 years, Lachlann has been CEO of 100 Story Building, a social enterprise providing creative learning opportunities for children and young people in Melbourne. Over 30,000 students have participated in its programs, supporting literacy skills development, confidence and sense of belonging. After 10 years leading 100 Story Building's growth, Lachlann recently relocated with his family to Queensland. SENVIC wishes to acknowledge Lachlann as an insightful, inclusive and innovative leader who has provided SENVIC with both strategic and practical guidance in its formative years. Lachlann has played a vital role in the establishment of SENVIC's governance, injecting the energy, ambition and innovation our community expects.
